ARTICLES OF INCORPORATION for

IGLESIA FUENTE DE SALVACION, INC.

(FOUNTAIN OF SALVATION CHURCH, INC.)

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I - Name

The name of the corporation shall be:

IGLESIA FUENTE DE SALVACION, INC.

(FOUNTAIN OF SALVATION CHURCH, INC.)

ARTICLE II - Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be:

ARTICLE III - Purpose(s)

The specific purposes for which the corporation is organized are:

- 1. To preach the Gospel of Jesus Christ and conduct Christian religious worship services on a weekly basis.
- 2. To celebrate and perform weddings, baptisms, dedications of children, the sacrament of the Holy Communion and any other religious services admissible by law.
- 3. To offer spiritual support and counseling services to people with marriage, family, drug and/or alcohol problems with the purpose of helping them to overcome their situations.
- 4. To provide emergency food and/or clothes to the homeless within the nearby community.
- 5. To conduct different recreational activities such as educational and spiritual retreats, sport, field trips, camping trips, picnics, hiking, and fishing for the members of our church.

ARTICLE IV - Manner of election of directors.

The method of election of directors shall be stated in the bylaws of this corporation.

ARTICLE V - Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

Iglesia Fuente de Salvación, Inc, is to have the power to do any and all things necessary or expedient for carrying out the purposes of this corporation, and in general to possess all rights, privileges and immunities, and to enjoy all the benefits granted to corporations of similar characters under the laws of the State of Florida. These powers shall include, but not be limited to:

- 1. Erect, purchase, enter into a lease agreement, and maintain and upgrade, business offices, and such other structures deemed necessary to carry out the overall purposes of this corporation.
- 2. Collect, solicit, and accept funds, gifts, and other subscriptions necessary to purchase, lease and maintain all facilities used for the stated purposes of this corporation as a nonprofit organization.
- 3. Publish Christian news, conduct Bible studies, church services, perform all Christian religious services including the rites of marriage and baptism, as well as any other activities and programs of Christian nature admissible by law.
- 4. Conduct all other powers necessary to carry out the general and specific purposes of the corporation.
