The undersigned does hereby certify, pursuant to the provisions of Section 617.1006, Florida Statutes, and in accordance with the provisions of Article XII of the Articles of Incorporation (the "Articles") of JIMMY EVERT TENNIS CENTER ADVISORY BOARD, INC., a not for profit corporation organized and existing under the laws of the State of Florida (the "Corporation"), said Articles which were filed with the Department of State of the State of Florida on September 9, 1999, that:

1. The name of this Corporation is JIMMY EVERT TENNIS CENTER ADVISORY BOARD, INC.
2. Article I of the Articles is hereby deleted in its entirety and replaced by the following:

"ARTICLE I - NAME"

The name of the Corporation shall be JIMMY EVERT TENNIS CENTER DEVELOPMENT FUND, INC. (hereinafter called the "Corporation")."

3. Except as hereby amended, the Articles shall remain unchanged.
4. Pursuant to Article VII of the Articles, the Corporation has no members.
5. These Articles of Amendment were duly adopted by a majority vote of the Board of Directors of the Corporation at a regular meeting of the Board of Directors on April 8, 2003, in accordance with Section 617.1002, Florida Statutes. These Articles of Amendment shall be effective as of the date these Articles of Amendment are filed.
