**ARTICLES OF INCORPORATION
OF
ASSOCIATION INTERNATIONALE DE SOLIDARITE, INC.**

The undersigned acting as incorporators of a corporation pursuant to chapter 617, Florida statues adopts the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be ASSOCIATION INTERNATINALE DE SOLIDARITE, INC.

ARTICLE II: PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be:
770 SouthWest 9th Street, Suite 4
Miami, Florida 33130

ARTICLE III: PURPOSE

The specific purposes for which the Corporation is organized are to:

- Contribute to the educational and social welfare of people who need assistance.
- Provide food and necessary life sustaining materials to children and adults in need in the United States and in other countries.
- In general, carry on any other incidental activity in connection with the above and to have and exerise all the powers conferred by the laws of the State of Florida, Department of State and the Florida not for Profit Corporation Act.
- Do any or all of the things herein before set forth to the same extent as a natural person might do.

The foregoing clause should be construed as both objects and powers and shall not be held to limit or restrict in any manner the powers of this Corporation. The Corporation is organized exclusively for charitable and educational purposes, including for the purposes of making distributions to organization that qualify as exempt organization under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any further federal tax code.

ARTICLE IV: MEMBERS OF THE ASSOCIATION

The association shall have four (4) categories of member:

- Founder
- Honor
- Active
- Partner

The member categories dues, eligibility and policies shall be defined by the By-Laws of the association.

ARTICLE V: MANNER OF ELECTION OF DIRECTORS

The Directors of the association shall be elected annually at the general assembly of the members in accordance with the By-Laws of the association.

The period of duration of the Corporation is perpetual.

ARTICLE VI: LIMITATION OF CORPORATE POWERS

The corporate powers of The Corporation are as provided in Section 617.0302, Florida Statutes.

ARTICLE VII: AMENDMENTS

The Corporation reserves the right to amend or repeal any, provisions contained in these articles of incorporation or any amendment to them.

ARTICLE VIII: INITIAL REGISTERED AGENT AND STREET ADDRESS
