- **ARTICLE III**
Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

To conduct ministry.

To spread the Gospel of the Protestant Christian religion through the following means: mission trips, work camps, and community services projects.

To conduct mission work through special events, concerts, festivals, as well as other means.

ARTICLE III is hereby amended to include the following in addition to the original provisions:

The Lord is Here, Inc. is organized to engage in activities in furtherance of any charitable or religious purpose, particularly those mentioned in this Article. No more than an insubstantial part of the activities can be other than in furtherance of an exempt purpose.

- **ARTICLE IV**
Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

Appointment to the Board of Directors by the request of specific individuals

ARTICLE IV is hereby amended to include the following in addition to the original provisions:

Each director may be elected to a one, two, three or four year term. No director is required to have the same term as any other director. The directors up for election will be elected by a majority vote of the directors in office immediately before such election. If the term that the director shall serve is not specified in the vote electing such director to office, the term shall be for one year. A director may be added to the board by a majority vote of the directors.

- **ARTICLE V**
Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited are as follows:

No Limitation

ARTICLE V is hereby amended by deleting the words "No Limitation" and inserting the following:

In addition to the limitation given in Article III, which provides that no more than an insubstantial part of the activities of this corporation can be other than in furtherance of an exempt purpose, any lobbying or other political activities are also forbidden.
