## ***Articles of Incorporation***

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

### Article I

The name of the corporation shall be Holy Tabernacle Church, Incorporated.

### Article II

The location of the church shall be 6416 Miriam Street, the city of Jacksonville, 32219 in the State of Florida the County of Duval .

### Article III

The purpose of this organization is purely religious, moral, uplifting, and civic.

### Article IV

The membership of the organization shall consist of only those who have met the requirements of the By-laws of the Holy Tabernacle Church, Incorporated. Said By-laws shall be presented to each and every member prior to them becoming members of the organization. The membership is not limited to male or female, and there is no age limit as to qualifications.

### Article V

The life of the corporation shall be perpetual.

### Article VI

The officers(Incorporators) of the corporation shall be elected annually by a majority vote of the members. Said elections shall be held the FOURTH week of each September.

Article VII

The By-laws of the Holy Tabernacle Church, Incorporated shall be made and acted upon in regular meetings assembled for the purpose of making By-laws. No By-laws shall be changed or amended in any way except by a majority of the members in regular meeting assembled for the purpose of amending or changing the By-Laws.

Article VIII

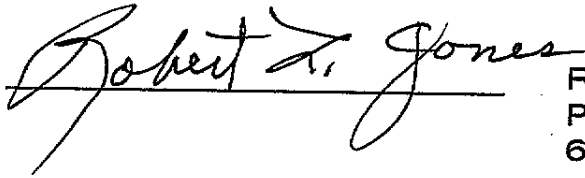
All of the business of the Holy Tabernacle Church, Incorporated shall be conducted by the Board of Directors who are the officers of the church.

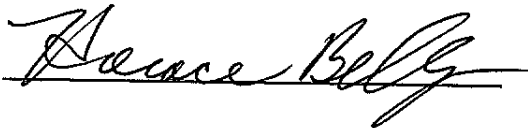

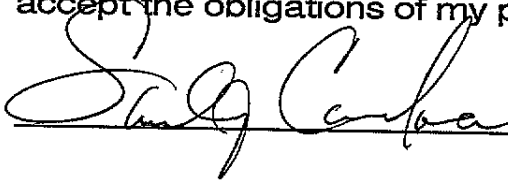
