ARTICLES OF INCORPORATION FOR GOLD COAST RINGERS, INC.

The undersigned, acting as incorporator of a not for profit corporation pursuant to Chapter 617, Laws of the State of Florida, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of this corporation shall be Gold Coast Ringers, Inc. The principal place of business of this corporation shall be 4508 Brandywine Drive, Boca Raton, Florida, 33487.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purpose for which the corporation is organized is to maintain a volunteer handbell ringing musical group that performs handbell music primarily at churches or other locations in Florida.

ARTICLE IV

The qualifications for members and the manner of their admission are set forth in the By-Laws.

ARTICLE V

The number constituting the initial Board of Directors of the corporation is six. The names and street addresses of the members of the first Board of Directors and officers, who are to serve initially are as follows:

ARTICLE VI

This corporation is organized under a non-stock basis.

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(C)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or the federal, state, or local government for exclusive public purpose.

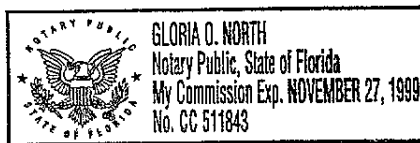
