ARTICLES OF INCORPORATION

OF

ZOE CHRISTIAN CENTER, Inc.

ARTICLE I NAME

The name of the corporation shall be: Zoe Christian Center, Inc.

ARTICLE II PURPOSE

- A. The purpose for which the corporation is to be formed are for scientific, educational, religious and charitable purposes within the meaning of Section 501 C (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Code law.
- B. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 C (3) of the Internal Revenue Code of 11986 or the corresponding provision of any future United States Revenue Law.
