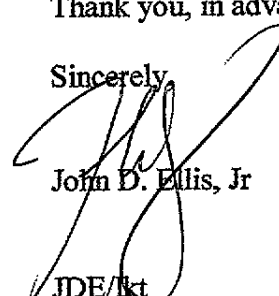

ARTICLES OF INCORPORATION
OF

ARTICLE I
NAME

The name of the corporation shall be: Zoe Christian Center, Inc.

ARTICLE II
PURPOSE

- A. The purpose for which the corporation is to be formed are for scientific, educational, religious and charitable purposes within the meaning of Section 501 C (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Code law.
- B. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 C (3) of the Internal Revenue Code of 11986 or the corresponding provision of any future United States Revenue Law.

ARTICLE III
TERM OF EXISTENCE

The duration of this corporation shall be: Perpetual.

ARTICLE IV
MANNER OF ELECTION OF DIRECTORS

The initial directors will be appointed by the incorporator to serve a one-year term. Following the expiration of the initial director's term the manner in which the directors will be elected or appointed will be set forth in the corporation's bylaws.

ARTICLE V
REGISTERED OFFICE, AGENT AND MAILING ADDRESS

The Registered office and Place of Business shall be 4566 Marshall Street, Orlando, Florida 32811. The Registered Agent shall be Carol J. Williams, whose address is 4566 Marshall Street, Orlando, Florida 32811. The mailing address of the corporation shall be P.O. Box 158, Winter Park, Florida 32789.

ARTICLE VI
AMENDMENTS.

Amendments to the Articles of Incorporation shall be adopted by a majority vote of the Board of Directors at any regular or special meeting called for that purpose and proposed by the Board of Directors to the membership. A majority vote of all members present and entitled to in the Bylaws of the corporation.

ARTICLE VII
DISSOLUTION

In the event this corporation shall be dissolved, said dissolution shall be in accordance with the laws of the State of Florida and any monies which may be left over shall pass directly to another charitable organization which, in and of itself, shall qualify under Section 501 C of the Internal Revenue Code of 1954, as amended.

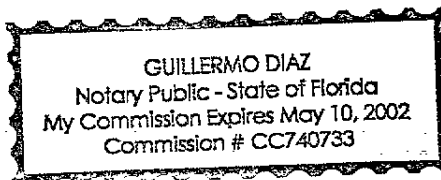
