FIRST AMENDMENT TO

## ARTICLES OF INCORPORATION

OF

GROVES AT BAYTREE HOMEOWNERS ASSOCIATION, INC.,

A FLORIDA CORPORATION NOT FOR PROFIT

DE HAY TO PHIZ: 46
Shung language Finding

WITNESSETH:

The name of the corporation is: GROVES AT BAYTREE HOMEOWNERS ASSOCIATION, INC.

In consideration of these premises, the aforesaid Articles of Incorporation of Groves at Baytree Homeowners Association, Inc., a Florida Corporation Not For Profit are amended as follows:

1. ARTICLE V - VOTING RIGHTS is deleted in toto and the following substituted therefor:

The Association shall have two (2) classes of voting membership as follows:

- A. THE CLASS "A" MEMBERS shall be all Owners of residences or dwelling units which have been constructed and conveyed to such Owners and shall be entitled to one (1) vote for each Residential Unit owned. When more than one (1) person holds an interest in any Residential Unit, all such Persons shall be members. The vote for such Residential Unit shall be exercised as the multiple owners may determine, but in no event shall more than one (1) vote be cast with respect to any one Residential Unit;
- B. THE CLASS "B" MEMBER shall be the Developer (as defined in the Declaration) and shall be entitled to three (3) votes for each subdivision lot owned and three (3) votes for each dwelling unit available to be constructed upon vacant unsubdivided parcels owned. The Class "B" Membership shall cease and be converted to Class "A" Membership upon the happening of either of the following events, whichever shall first occur:
  - (1) At such time as Developer elects; or
- (2) When Developer, including Successor Developers, in the ordinary course of business, has conveyed title to eighty (80%) percent of the Lots approved for Groves at Baytree Subdivision in accordance with the Master Plan or Planned Unit Development, and which are subject to or which will be subjected to control of the association upon platting.

- 2. ARTICLE VI DIRECTORS; Paragraph C. thereof is deleted in toto and the following substituted therefore:
- C. The directors named in these Articles shall serve until the first election of directors, and any vacancies in their number occurring before the first election shall be filled by the remaining directors.

The above amendments were adopted by more than a two-thirds (2/3) vote of the voting membership on April 25, 2006, and the number of votes cast for the amendment were sufficient for approval thereof.

All other provisions of the said Articles of Incorporation not amended hereby remain in full force and effect.
