**ARTICLES OF INCORPORATION**

**OF**

**THE RAYMOND C. ROACH CHRISTIAN SCHOLARSHIP FUND, INC.**  
**(a corporation not-for-profit)**

THE UNDERSIGNED, acting as sole incorporator of a corporation to be formed under the Florida Not For Profit Corporation Act, and who is a citizen of the United States, adopts the following Articles of Incorporation:

FIRST: The name of the corporation (the "Corporation") is:

The Raymond C. Roach Christian Scholarship Fund, Inc.

SECOND: The initial principal office and mailing address of the Corporation is:

13370 Southampton Drive  
Bonita Springs, Florida 34135

THIRD: The term for which the corporation is to exist shall be perpetual or until such time as the Corporation shall have been dissolved in accordance with the laws of the State of Florida.

FOURTH: The Corporation is organized for the purpose of engaging in any lawful act or activity for which corporations not for profit may be formed under the Florida Not For Profit Corporation Act. In addition, the Corporation is organized exclusively for charitable, religious, educational, and scientific purposes as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, and the Corporation will have as its purpose the awarding of scholarships to high school and college students based on need, scholastic achievement, citizenship and other criteria set forth in the bylaws of the Corporation. The Corporation shall not carry on, other than as an insubstantial part of its activities, activities which are not in furtherance of one or more charitable purposes.

FIFTH: The address of the initial registered office of the Corporation is:

SIXTH: The manner in which the directors are to be elected or appointed shall be as stated in the bylaws of the Corporation.

EIGHTH: On dissolution of the Corporation, the assets shall be distributed for one or more charitable purposes, to organizations qualifying as tax-exempt publicly supported organizations.
