**ARTICLES OF INCORPORATION
OF
TAMPA BAY RAIDERS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is TAMPA BAY RAIDERS, INC., and the principal address and principal place of business is 5473 Jetport Industrial Blvd., Tampa, Florida 33634.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o STEVEN W. MOORE, P.A., 2240 Belleair Road, Suite 100, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is Steven W. Moore, Esquire.

ARTICLE III - PURPOSE

The corporation is organized exclusively for the education, well being, development of young children through athletic and sport related activities.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The Directors shall be elected on an annual basis by the members of the corporation. The duties, removal of and restrictions concerning the Directors, shall be governed by the Bylaws.
