## ARTICLES OF INCORPORATION OF CLEARWATER ARTS! FOUNDATION, INC.

The undersigned by these Articles associate themselves for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, and certify as follows:

#### ARTICLE I. NAME

The name of the corporation, hereinafter called the "Corporation", shall be CLEARWATER ARTS! FOUNDATION, INC.

#### ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 1130 Cleveland Street, P.O. Box 2457, Clearwater, Florida 33757.

#### ARTICLE III. PURPOSES

The specific purposes for which the corporation is organized are exclusively for educational, charitable, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 and to that end to promote public support and presentation of artistic and cultural events and activities within the City of Clearwater, Florida, including the visual arts, music, architecture and preservation of historic buildings and sites, to provide venues for such events and activities, and to encourage and support the establishment and maintenance of art museums within the City of Clearwater.

#### ARTICLE IV. LIMITATIONS AND RESTRICTIONS

A. No part of the net earnings of the Corporation shall inure to the benefit of any member, Director, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes), and no member, Director, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the

activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

- B. Notwithstanding any other provision of these Articles, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170(c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.
- C. Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation remaining after payment of all costs and expenses of such dissolution shall be distributed exclusively to charitable, religious, scientific, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, and none of the assets will be distributed to any member, officer or director of the Corporation or to any private individual.

#### ARTICLE V. TAX EXEMPT STATUS

It is intended that this corporation shall have the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code as an organization described in Section 501(c)(3) of the Internal Revenue Code, and which is other than a private foundation by reason of being described in Section 509(a)(1), (2), or (3) of the Internal Revenue Code. These Articles shall be construed accordingly, and all powers and activities of the Corporation shall be limited accordingly.

#### ARTICLE VI. TERM

This Corporation shall exist perpetually, unless dissolved according to law.

#### ARTICLE VII. MEMBERS

The members of the Corporation shall constitute all persons hereinafter named as subscribers and directors and such other persons as, from time to time hereafter, may become members, in the manner provided in the Bylaws of the Corporation or as may be elected by the members at each annual meeting.

#### ARTICLE VIII. DIRECTORS

There shall be ten initial Directors of the Corporation, as follows:

Said initial Directors shall hold office until their successors are elected and have qualified, or until removed.

#### ARTICLE IX. OFFICERS

The Officers of the Corporation shall be as provided in the Bylaws.

#### ARTICLE X. MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed shall be as provided in the Bylaws.

#### ARTICLE XI. INITIAL REGISTERED AGENT

The initial registered agent of the Corporation shall be Lynn Wargo, located at 1130 Cleveland Street, P.O. Box 2457, Clearwater, Florida 33757.

#### **ARTICLE XII. BYLAWS**

The Board of Directors of the Corporation shall make, adopt, alter, amend and repeal such Bylaws of the Corporation for the conduct of the business of the Corporation and the carrying out of its purposes as such Directors may deem necessary from time to time. The Bylaws may be altered, amended or repealed at any meeting of members of the Corporation in the manner provided in the Bylaws.

#### ARTICLE XIII. AMENDMENT OF ARTICLES OF INCORPORATION

The power to alter, amend, or repeal the Articles of Incorporation of this Corporation is vested in the Board of Directors. Such action must be taken pursuant to a resolution approved by vote of two-thirds of all of the Directors.

### ARTICLE XIV. DEFENSE AND INDEMNIFICATION OF OFFICERS AND DIRECTORS

The Corporation shall defend, indemnify, and hold harmless every registered agent, director, or officer, any Executive Director, his or her heirs, executors, and administrators against liability and against expenses reasonably incurred in connection with any action, suit, or proceeding to which such individual or individuals shall be made a party by reason of being or having been a director, officer or Executive Director of the Foundation, except with regard to such actions or matters that such individual shall have been finally adjudicated in such action, suit, or proceedings to be liable for willful misconduct. The foregoing right shall be exclusive of any other rights to which such individual may be entitled.
