

ARTICLES OF INCORPORATION

OF

GUARDIAN ANGELS LIVING SERVICES, INC.

ARTICLE I. NAME

The name of this corporation is GUARDIAN ANGELS LIVING SERVICES, INC.

ARTICLE IL DURATION

This corporation shall commence January 1, 2000 and shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 1000 shares of \$1.00 par value common stock, which shall be designated "common shares".
