ARTICLES OF INCORPORATION
OF
DSAssociates, Inc.

THE UNDERSIGNED, acting as sole incorporator of DSAssociates, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

The name of the corporation shall be DSAssociates, Inc. and the corporate address shall be 7628 Southwick Dr., Orlando, FL 32818.

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purposes

The purpose of the corporation is to engage in any acts or activities for which a corporation may be organized under Chapter 607 of the Florida Statutes.

ARTICLE IV

Shares

The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000) consisting of a single class of common stock, One Dollar (\$1.00) par value.

ARTICLE V

Initial Board of Directors

The number of Directors may be increased or decreased from time to time, but in no event shall the number of Directors be less than one (1).
