ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a Professional Corporation (hereinafter referred to as the "Corporation") under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

Article I: The name of the corporation shall be Page, Mrachek, Fitzgerald & Rose, P.A..

Article II: The principal place of business and mailing address of this corporation shall be Flagler Center, 505 South Flagler Drive, Suite 200, West Palm Beach, FL 33401.

Article III: The number of shares of stock that the corporation is authorized to have outstanding at any one time is 300, all of which are without par value and classified as Common shares.

Article IV: The name and address of the initial registered agent is NRAI Services, Inc. 526 East Park Avenue, Tallahassee, Florida 32301.

The written acceptance of the initial registered agent, as required by the provisions of Section 607.0501(3) of the Florida Business Corporation Act, is set forth following the signature of the incorporator and is made a part hereof.

Article VII: The period of duration of the corporation is perpetual.

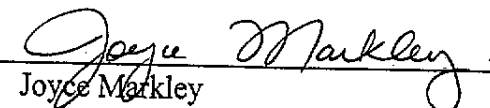

Such indemnification provided shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, Agreement or Resolution adopted by the shareholders entitled to vote thereon after notice.
