On January 26, 2004, the Board of Directors of DRUGON BIOTECH CORPORATION passed a resolution that Article I of the Articles of Incorporation be amended. On January 27, 2004, a majority of the Shareholders adopted the recommendation of the Company's Board of Directors and by consent, approved this Amendment to the Articles of Incorporation of DRUGON BIOTECH CORPORATION. The corporation is filing these Articles of Amendment to the Articles of Incorporation, pursuant to F.S. 607.1006.

1. The name of the corporation is DRUGON BIOTECH CORPORATION.
