ARTICLES OF INCORPORATION OF ACORN TRANSCRIPTIONS, INC.



ARTICLE I

The name of the corporation is Acorn Transcriptions, Inc.

ARTICLE II

Its initial registered office and principal office in the State of Florida is 3572 Acorn St., in the city of North Port, County of Charlotte. The name of the initial registered agent at such address is Nancy Gardelli.

ARTICLE III
