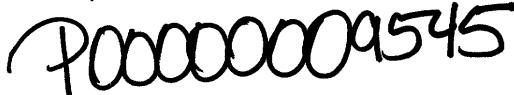

# ARTICLES OF INCORPORATION OF Amena Realty, Inc
