

AMENDMENTS





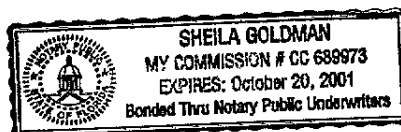
