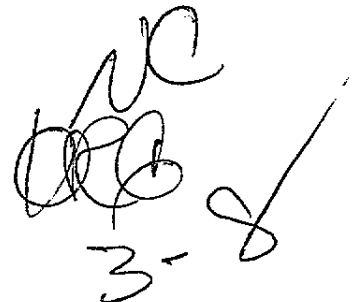

ARTICLE I NAME

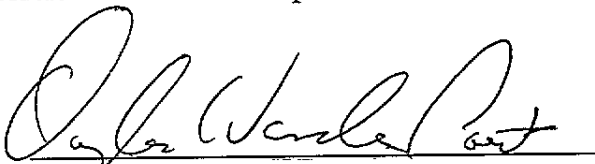
The name of this corporation is SPACE COAST HOCKEY, INC.
