

The undersigned, who, if a natural person, is eighteen years of age or older, hereby establishes a corporation pursuant to the Florida Business Corporation Act, as amended, and adopts the following Articles of Incorporation:

Article I. Corporate Name

The name of this corporation is B B & B Investments, Inc.

Article II. Duration

The corporation shall be effective immediately upon filing of the Articles of Incorporation with the Department of State, and shall exist perpetually.

Article III. Purpose
