ARTICLES OF INCORPORATION

OF

EFFECTIVE DATE

FIRST SOUTH HOLDINGS, INC

The undersigned, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - NAME:

The name of the Corporation is FIRST SOUTH HOLDINGS, INC.

ARTICLE II - PRINCIPAL BUSINESS ADDRESS:

The principal place of business and mailing address of the Corporation is 1467 Piedmont Drive East, Suite B, Tallahassee, Florida 32312.

ARTICLE III - COMMENCEMENT AND DURATION:

The corporation is to commence its corporate existence on the date of subscription and acknowledgment of these articles of incorporation and shall exist perpetually thereafter until dissolved according to law.
