"ARTICLE I

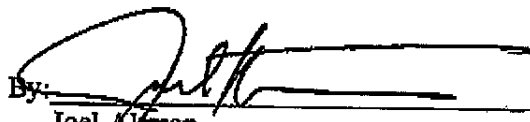
The name of this Corporation is ALTMAN CONTRACTORS, INC."
