## ARTICLES OF INCORPORATION.

#### ARTICLE 1: NAME & ADDRESS

#### <u> ARTICLE 2: DURATION</u>

The corporation shall exist perpetually. In accordance with section 607.0203, the date when existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

#### **ARTICLE 3: PURPOSE**
