Pursuant to Section 607.1403, Florida statute, the undersigned corporation has determined to dissolve as of June 30, 2000.


FIRST: The name of the corporation is Cyber Bar, Inc..

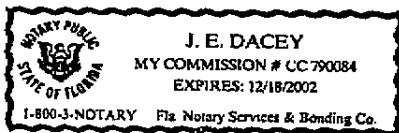
