ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF

3. Article VI of this Corporation's Articles of Incorporation is hereby amended in its entirety so as to read, after amendment, as follows:

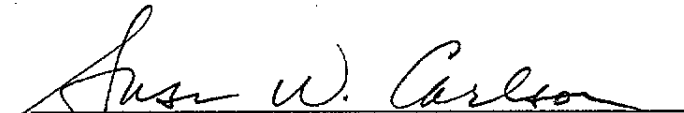
"ARTICLE VI
