ARTICLES OF INCORPORATION

OF

DESTINI OF BREVARD, INC.

ARTICLE I – NAME

The name of this corporation is DESTINI OF BREVARD, INC. The address of this corporation is 2006 SYKES CREEK DRIVE, MERRITT ISLAND, FLORIDA 32953.

ARTICLE II – DURATION

This corporation shall exist perpetually. The date of commencement of the corporation shall be MARCH 1, 2000.

ARTICLE III – PURPOSE

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

ARTICLE IV – CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$5.00 par value common stock.

ARTICLE V – PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which is already held, shall have the right to purchase their pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI – INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 2006 SYKES CREEK DRIVE, MERRITT ISLAND, FLORIDA, 32953. The name of the initial registered agent of this corporation at that address is LOUIS RIPOSTA.

ARTICLE VII – INITIAL BOARD OF DIRECTORS

This corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by the bylaws but shall never be less than one. The names and addresses of the initial directors are:

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

ARTICLE X – COMPENSATION OF DIRECTORS


The shareholders of this corporation shall have the exclusive authority to fix the compensation of the directors of this corporation.
