Name

The name of this corporation is A LOTTA & A LITTLE, INC.


ARTICLE X

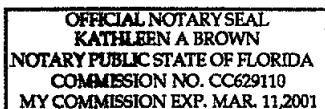
