In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is SEJ PROPERTIES, INC..

ARTICLE II

The existence of the Corporation shall begin on March 7, 2000.

ARTICLE III

The street address of the principal office of the Corporation is 605 Commercial Drive, Holly Hill, Fl 32117.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 2500, par value \$1.00 per share, all of which shall be Common Shares. 


The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
