**Articles Of Incorporation
Of

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME AND PRINCIPAL OFFICE

The name of the corporation shall be: A Woman's Excursion, Inc. The address of the principal office of this corporation shall be 805 Virginia Avenue, Suite 8, Fort Pierce, 34982, and the mailing address of the corporation shall be the same.

ARTICLE II - NATURE OF BUSINESS

This corporation is formed to engage in every phase and aspect of the insurance agency business, and may transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III - TERM OF EXISTENCE

This corporation is to exist perpetually.
