ARTICLE I

NAME

The name of this corporation is NTWebs, Inc.

ARTICLE II

PURPOSE

This corporation is organized for the following purposes:

1. To engage in any activity or business permitted under the laws of the United States and the State of Florida.
2. To engage in manufacturing, selling, consulting, and development of computer and communications equipment, software, web services, internet access and investment business and to do any and all things incidental thereto.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue One Thousand (1,000) shares of common stock.

The common stock of the corporation shall have the following characteristics:

- (a) Par value shall be One (\$1.00) Dollar per share.
- (b) At all meetings of the stockholders, the common stockholders shall be entitled to cast
  - (1) vote for each share of common stock owned. That a common stockholder is interested in a matter to be voted upon shall not disqualify him from voting thereon.
- (c) Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common stock.

#### **ARTICLE IV**

##### **TERM OF EXISTENCE**

This corporation shall have perpetual existence commencing on the 8<sup>th</sup> day of March, 2000, the date of execution and acknowledgment of these Articles of Incorporation.

#### **ARTICLE V**

##### **INITIAL REGISTERED OFFICE AND AGENT**

The address of the initial office of this corporation is 2045 North West First Place, Boca Raton, Florida, and the name of the initial registered agent of this corporation at that address is MARIA GEORGE. The Board of Directors may, from time to time, change the street and post office address of the corporation as well as the location of its principal office.

#### **ARTICLE VI**

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, in the manner provide by law.

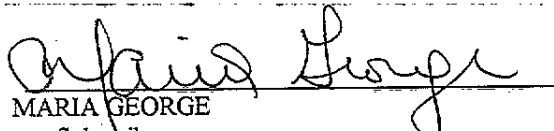

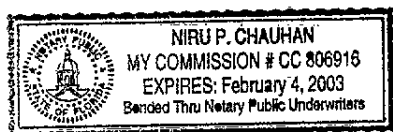

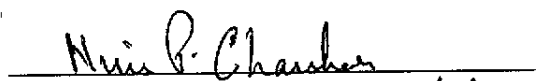
