**FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE**

**THIS CAUSE** having come before this Court upon final hearing, and the Court having heard the testimony from the Petitioner/Husband, **EDWARD J. GOLDFARB**, and the Court having reviewed the parties' duly executed Marital Settlement Agreement as dated, and having entered same into evidence this day, and the Court having found same to be fair, reasonable and just and being otherwise fully advised in the premises, it is, thereupon

**ORDERED AND ADJUDGED** as follows:

1. That the bonds of marriage between the Petitioner/Husband, **EDWARD J. GOLDFARB**, and the Respondent/Wife, **BARBARA A. GOLDFARB**, be and are hereby dissolved, a vinculo matrimonii.

2. That the Marital Settlement Agreement dated January <sup>8th</sup> 8, 2001, a copy of which is attached to this Final Judgment and which is incorporated herein by reference and made a part of this Final Judgment as Exhibit "A", was entered into by the parties voluntarily and after full financial disclosure, and is in best interest of the parties and therefore is approved by this Court.

3. The parties are ordered and directed to comply with all of the terms and conditions that are set forth in the Final Judgment and the incorporated Marital Settlement Agreement.

4. The Wife's former name is restored and she shall be known as **BARBARA A. BLAIS** hereafter.

5. This Court retains jurisdiction over the parties and the subject matter of this action for the purpose of entering any further Order that may be equitable, appropriate and just and to enforce any of the terms and conditions of the Final Judgment and incorporated Marital Settlement
