# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF eXPRESS WALK-IN MEDICAL CENTER, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida for-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Amendments Adopted:

#### (1) ARTICLE III:

Shareholder, DR. MARCOS ZARAGOZA, M.D. (misspelled as "DR. MARCOS ZARAGUSA, M.D."), is deleted as well as his 125 shares of stock; the remaining persons continue as shareholders; no changes as to the remaining distribution of stock.

#### (2) ARTICLE VIII
