**ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME AND PRINCIPAL PLACE

The name of the corporation is THE SANDBLASTING SHOP, INC. The principal place of business of the corporation shall initially be 4375 Progress Avenue, Bay 409, Naples, Florida 34104.

ARTICLE II

DURATION

The corporation shall have perpetual existence.

ARTICLE III

PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV

CAPITAL STOCK

The corporation is authorized to issue 1,000 shares of \$0.10 par value common stock, which shall be designated "common shares".

ARTICLE V

PREEMPTIVE RIGHTS

The corporation elects to have preemptive rights.

ARTICLE VI

INITIAL REGISTERED OFFICE AND AGENT

These Articles of Incorporation shall be effective upon the date of filing and acknowledgement.

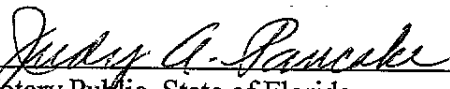

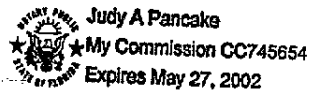
