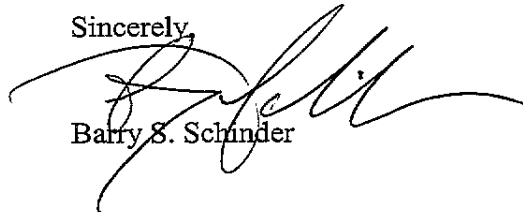

CORPORATE NAME

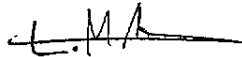

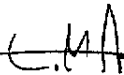
