The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the Corporation is:

The powers to adopt, alter, amend or repeal the Bylaws shall be vested in the Board of Directors.

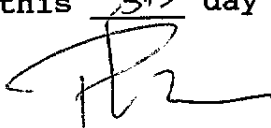
**ARTICLE XI - INDEMNIFICATION**

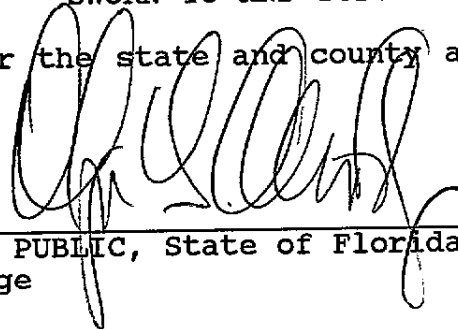

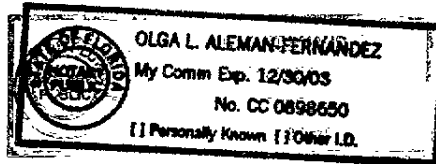
