The undersigned hereby organizes a professional corporation for profit under the provisions of Chapters 607 and 621, Florida Statutes, and pursuant to the following Articles of Incorporation.

ARTICLE 1

Name

The name of this corporation is:

ARTICLE 2

Nature of Business

The general nature of the business to be transacted by the corporation shall be to engage in every aspect of the practice of law.
