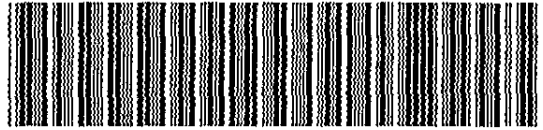



**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION


The name of this corporation is Knopik, Varner & Moore, P.A.


