ARTICLES OF INCORPORATION

OF

G. GAY LEGE', P.A.

The undersigned natural person, who is licensed to sell real property in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following articles of incorporation for such corporation.

ARTICLE I - CORPORATE NAME AND PRINCIPAL OFFICE

The name of this corporation is G. GAY LEGE', P.A., and its principal office and mailing address is 15 Beach Drive East - Gulf Pines, Destin, Florida 32541

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE AND POWERS

This corporation is organized for the purpose of marketing and selling real property and to perform on services incident thereto.

In connection with the above-mentioned purpose, the corporation shall have the power to invest its funds in real estate, mortgages, stocks, bonds, or any other type of investments, to own real or personal property, and to exercise all other rights and powers now or hereafter conferred on professional corporations by the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK
