ARTICLE I - NAME

The name of the Corporation is Plantation Subway, Inc

The registered agent shall be Idris Mysorewala at 7742 Peters Rd. Plantation, FL 33318


ARTICLE VI – BOARD OF DIRECTORS



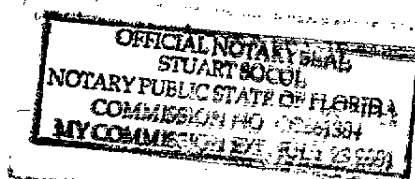
