

The undersigned, for the purposes of engaging and organizing a corporation under the laws of the State of Florida, does hereby associate themselves and adopt the following Articles of Incorporation for such corporation:

- I. NAME: The name of the corporation shall be FLORIDA WINTER BASEBALL LEAGUE, INCORPORATED, and it is to be located at 5330 Spring Hill Drive, Suite H, Spring Hill, Hernando County, Florida 34606.
- own and operate a baseball league and all other activities associated with the business. The corporation shall be authorized and able to do all lawful business which the laws of the State of Florida allow for corporations organized under the laws of the State of Florida.
