ARTICLES OF INCORPORATION  
FOR

ARTICLE ONE

The name of the corporation is Yochum Automotive Enterprises.

The period of its duration is perpetual.

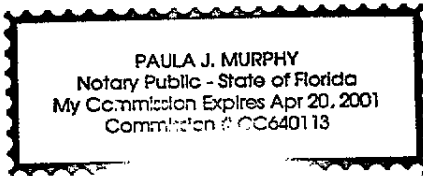




