**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of **J. RAYMOND CONSTRUCTION CORP.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

**ARTICLE II
SHARES**
