**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
J. RAYMOND CONSTRUCTION CORP.**

The undersigned, the President of J. RAYMOND CONSTRUCTION CORP., a Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act, states as follows:

1. The name of the Corporation is J. RAYMOND CONSTRUCTION CORP.
2. The Articles of Incorporation of the Corporation are amended by deleting Article II in its entirety and inserting the following Article II in its place and stead:

**"ARTICLE II
SHARES**

The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having a par value of \$0.01 per share, of which 5,000 shares shall be designated as voting common stock and 5,000 shares shall be designated as nonvoting common stock."

3. The amendment to the Articles of Incorporation of the Corporation was approved by written consent of the holders of a majority of the voting common stock, which approval became effective on June 14, 2013.
