ARTICLES OF INCORPORATION
OF
MULTIFLORA CORPORATION

The undersigned, acting as incorporator of MULTIFLORA CORPORATION under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is MULTIFLORA CORPORATION (the "Corporation").

ARTICLE II. ADDRESS

The mailing address of the Corporation is 701 Brickell Ave., Suite 3000, Miami, Florida 33131.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the Corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The Corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the Corporation is authorized to have outstanding at any time is 100,000 shares of common stock having a par value of \$.01 per share.
