The undersigned incorporator, KEITH M. KUNDAHL, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

**ARTICLE I - NAME**

The name of this corporation is KUNDAHL KOMPANIES, INC.

**ARTICLE II - PRINCIPAL OFFICE**

The address of the principal office of the corporation is 3400 Oakmont Drive, Pensacola, Florida 32503.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

**ARTICLE IV - CAPITAL STOCK**
