ARTICLES OF INCORPORATION

OF

MEASURE UP FLOORING SERVICE, INC.

ARTICLE I

Name and Mailing Address. The name of this corporation is MEASURE UP FLOORING SERVICE, INC. The street address of the principal office of this Corporation is 1636 Oviedo Grove Circle, Apartment 2, Oviedo, Florida 32765, and its mailing address is P.O. Box 622558, Oviedo, FL 32762-2558.

ARTICLE II

<u>Business and Activities.</u> This corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

<u>Capital Stock.</u> The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand (1,000) shares of common stock having a par value of \$1.00 per share, with the consideration to be paid for each share to be in money, property or services, as may be fixed by the Board of Directors.

ARTICLE IV

<u>Term of Existence</u>. This corporation shall have perpetual existence.

ARTICLE V

<u>Initial Registered Office and Agent.</u> The street address of the initial registered office of this corporation is 1132 Symonds Avenue, Winter Park, FL 32789 and the name of the initial registered agent of this corporation at that address is GARY M. BERKSON.

ARTICLE VI

<u>Preemptive Rights.</u> Every stockholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to

purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII

Number of Directors. The Board of Directors of this corporation shall consist of one or more directors, the exact number of which shall be the number of directors from time to time fixed by the Board of Directors or the shareholders in accordance with the Bylaws of the corporation. Directors, as such, shall receive such compensation for their services, if any, as may be set by the Board of Directors at an annual or special meeting. The directors may authorize and require the payment of the reasonable expenses incurred by directors in attending meetings of the directors. Nothing in this Article shall be construed to preclude a director from serving the corporation in any other capacity and receiving compensation therefor.
