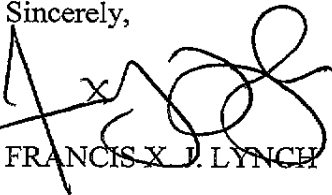

ARTICLES OF INCORPORATION
OF
WISTERIA MANAGEMENT SERVICES, INC.

Pursuant to Florida Statute Section 607.1007, WISTERIA MANAGEMENT SERVICES, INC., a Florida Corporation (the "Corporation"), certifies that:

1. The original Articles of Incorporation of the Corporation were filed by the Department of State on May 19, 2000.
2. The Amended and Restated Articles of Incorporation were duly adopted by the Corporation's Board of Directors on April 26, 2002.
3. The Articles of Incorporation are amended as follows:

- A. Article 1 is amended to change the name of the Corporation to:

MICHELE P. KUKLA, P.A.

- B. Article 2 is amended to change the principal address of the corporation to:

6198 Winding Lake Drive
Jupiter, Florida 33458

- C. Article 4 is amended to change the registered office and registered agent to:

Michele P. Kukla
6198 Winding Lake Drive
Jupiter, Florida 33458

- D. A new Article 6 is added limiting the scope of services which the Corporation is able to provide to:

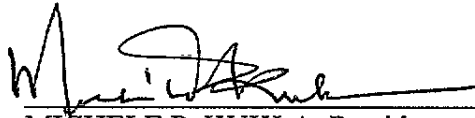
those services permitted to be performed by a licensed property manager, a licensed real estate sales person and a licensed real estate broker.

4. These amendments to the Articles of Incorporation were duly adopted by the shareholders of the Corporation on April 26, 2002.
5. There are no discrepancies between the provisions of the Articles of Incorporation, as amended, and the provisions of these Amended and Restated Articles of Incorporation other than the inclusion of the foregoing amendments, which were adopted pursuant to Florida Statute Section 607.1003 and the omission of matters of historical interest.

The text of the Articles of Incorporation of the Corporation is restated with the amendments described above, effective as of the date of filing with the Department of State, to read as follows:

1. The name of the corporation is MICHELE P. KUKLA, P.A. (the "Corporation").
2. The street address of the corporation is 6198 WINDING LAKE DRIVE, JUPITER, FLORIDA 33458.
3. The aggregate number of shares which the Corporation is authorized to issue is 7,500 shares of common stock having a par value of \$.01 per share.
4. The street address of the registered office of the Corporation is 6198 WINDING LAKE DRIVE, JUPITER, FLORIDA 33458 and the registered agent is MICHELE P. KUKLA.
6. The specific nature of the business of the Corporation is the performance of those services permitted to be performed in the State of Florida by a licensed property manager, a licensed real estate salesperson and a licensed real estate broker.
