**ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of the professional association is:

JACK MARTIN COE, P.A.

ARTICLE II - DURATION

The professional association shall exist in perpetuity.

ARTICLE III - PURPOSE

The professional association is organized for the purpose of rendering professional legal services and transacting any or all other lawful business as enumerated in Section 621.08, Florida Statutes.

ARTICLE IV - CAPITAL STOCK
