ARTICLES OF INCORPORATION OF ADVANCED PETROLEUM SERVICES, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be ADVANCED PETROLEUM SERVICES, INC.

ARTICLE II - PURPOSES

The purposes for which the corporation is organized is to service or repair petroleum or gasoline pumps, containers, equipments, etc., to separate water or other impurities from petroleum or gasoline, or to transact any or all lawful business for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE III - AUTHORIZED SHARES
